MUNICIPAL INFO

On behalf of the Municipal Council, I am proud to present the 2024 budget for the Municipality of Elgin.

The current economic context makes us more aware of the importance of constantly maintaining rigorous management of public funds. We must remain vigilant while continuing to offer quality services to all of our citizens. This is our mission.

The new property assessment roll has been deposited. This new role updates property values in Elgin based on the current real estate market. The new role forces the municipality to lower its basic tax rate.

For the year 2024, the tax rate will be \$0.3924 per \$100 of assessment, a reduction of \$0.1667 per \$100 of assessment.

The cost of garbage collection will be \$175, a slight increase compared to last year and the cost of recycling will remain at \$95.00 per unit.
