APPLICATION FOR PERMITS AND CERTIFICATES


This is a reminder that before carrying out renovation, expansion or construction work, even if you are planning to demolish whether for your home, your garage, an agricultural building or a shed, the installation of a swimming pool, a silo, for a well or a septic system you must always obtain a permit **beforehand**. You need to apply for your permits in advance! Please note that the inspector has thirty (30) days to issue a permit or certificate of authorization.

Work carried out without a permit may not comply with the standards and regulations in force. Anyone who undertakes work without the necessary permits or authorizations can be given a ticket or a fine, and even demolition could be ordered.

- Carry out any other related tasks at the request of your superior.

REQUIREMENTS:

- Must be able to get around
- -The ability to work in a team
- Must have a valid driving license (class 5)
- Be able to work in varied climatic conditions (heat, humidity, rain, etc.)
- Be available during normal business hours.
