In accordance with the provisions of article 176.2.2 of the Municipal Code of Quebec, I submit my report on the highlights of the Municipality of Elgin for the fiscal year ending December 31, 2023. The data contained in this report comes largely from the external accounting audits which provide a compliant and transparent picture of the accounting operations of the municipal administration.

The financial report, audited by the firm of chartered professional accountants BCGO s.e.n.c.r.l. was tabled at a regular Council meeting on September 9, 2024, and sent to the Ministry of Municipal Affairs. THE INDEPENDENT AUDITOR'S REPORT

Following the completion of his mandate, the auditor, in the independent auditor's report, is of the opinion that with the exception of the fact that the municipality has not assessed or recorded any liability for obligations related to the decommissioning of fixed assets, the consolidated financial statements present fairly, in all material respects, the financial position of the Municipality of Elgin as of December 31, 2023, and the results of its operations, changes in its net financial assets (net debt) and its cash flows for the year then ended in accordance with Canadian public sector accounting standards.

THE FINANCIAL REPORT

The financial statements of the municipality as of December 31, 2023, a summary of which you will find below, indicate operating revenues for the municipal administration of \$1,067,452, while operating expenses, excluding depreciation, were \$848,549. Taking into account the various reconciling items for tax purposes (amortization, debt repayment, allocation, etc.), results in an operating surplus for the year for tax purposes of \$208,543 as audited by the independent auditor.
